Through different modes of investment and EPC contracting, we have undertaken many energy and power engineering projects across dozens of international markets, establishing a portfolio of operable assets primarily centered around clean power generation. Presently, we hold a clean power generation installed capacity of approximately 4,000 MW in key markets such as Europe and South Asia. Looking ahead to the next 3 years, the total installed capacity of our upcoming projects, predominately focusing on wind, solar, and natural gas power generation, is projected to be around 8,000 MW.

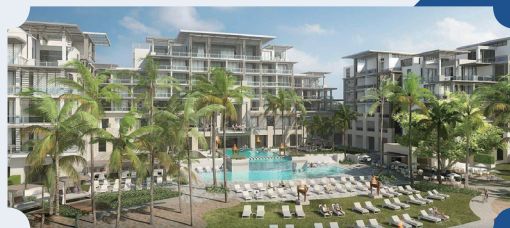
### Maqiao Regenerated Resource Utilization Project in Shanghai

## BRICS Responsibilities



Genertec serves as a member of the BRICS Business Council and the head unit of the Trade and Investment Working Group (Chinese side). It bears the historic responsibility of implementing, developing, and constructing BRICS. In collaboration with the Ministry of Industry and Information Technology (MIIT), Genertec initiated the establishment of the BRICS Partnership on New Industrial Revolution (PartNIR) Innovation Center Industry Innovation Alliance. Additionally, it co-founded the BRICS PartNIR Innovation Center Industry Fund with the Xiamen Municipal Government and promoted the construction of the headquarters area of the BRICS PartNIR Innovation Center.

### BRICS Business Council
